An Order of interim injunction of this Honorable Court restraining defendant/respondents from conducting, organizing, attending and/or preparathe Extra-Ordinary General Meeting to remove the ist Claimant without restrict to the 1st claimant and against the Bye Law of the 2nd claimant pend hearing of the interlocutory injunction in this suit.
- 2. Andfor such Order or Orders as the Honorable Court may deem fit to make in the circumstance.

The motion paper is supported by a 19-paragraph affidavit in support deposed to by Ademola Adebusuyi, the current President of the NNPC (Staff) Cooperative Multipurpose Society Limited. Attached are several exhibits marked as Exhibit AA1, AA2, AA3, AA4. As required by the rules a written address was also filed 17/01/2024 alongside the motion paper. The address is settled by a team of lawyers lead by Badmos Oyetunji, esq. et al. GA

I have carefully considered the facts placed before the Court as contained in the Affidavit of Urgency and the Affidavit in Support.

This Court is satisfied that cogent and compelling facts have been placed before the Court to anchor the exercise of discretion in favour of the applicant. It is apparent that the applicant who is currently the President of the 2nd claimant, ought not to be subjected to a procedure offensive to the rules and regulations as contained in the Bye Laws of the Cooperative.

I accept the contention of learned counsel for the applicants that a grant of the reliefs sought does not prevent the removal of the 1st claimant from office, but only ensures that self help measures are not allowed to override laid down procedure as contained in the Clause 5.4of the Bye Laws governing the operations of the 2nd claimant.

The balance of convenience certainly tilts in favor of the claimant and accordingly the reliefs sought are granted to wit:
